NOW, WHEREFORE, for and in consideration of the mutual promises herein set forth, and for other good and valuable consideration receipt of which is hereby acknowledged, it is agreed as follows:

YOU AGREE TO BE BOUND BY THE TERMS OF THIS SOFTWARE LICENSE, WITHOUT EXCEPTION, BY INSTALLING, COPYING, OR OTHERWISE USING THE SOFTWARE. 1. License

You and Verifysoft expressly consent to the personal jurisdiction and exclusive venue therein.

Except as set forth herein, the exercise by either party of any of its remedies provided for herein will be without prejudice to such other remedies as may be provided herein or otherwise.
